### Watercare – Follow up on question from previous meeting

We were informed that the existing ponds will be decommissioned and filled in as part of the project. Is this a consent issue or are there other factors necessitating the filling in of the ponds? The reason for asking is that the quiet location has become a default roosting area for some of our shore bird species that have been displaced from Snells Beach due to increased human activity. We are also aware that other non endemic species such as geese have also found use for the ponds. Was any consideration given to an alternative use for the ponds such as a wetlands area Watercare have acknowledged our request for information regarding the future of the ponds. At this point in the project, Watercare cannot respond to our request as the completion of the pipeline interconnection is delayed. Watercare are keeping their options open and will formally reply to our request as the project progresses.

### Shorebird information panels: - Diane Taylor

- Slowly progressing with the feasibility study.
- SBRRA attended the recent "Welcome to the Godwits" event. Community response to the suggestion of information panels along the waterfront very positive.

- June Turner commented that a better location for the course may be at the end of Te Whau walkway off Dawson Road. Her concern was the prospect of sharing the course with off leash dogs on Te Whau Reserve

# AC report – Cr Greg Sayers

- A thank you for the support he received in the recent elections. Is proud to be able to continue to support and be an advocate for Rodney
- He has had 2 meetings with the new mayor Wayne Brown, and finds him supportive of the rural areas in Auckland City Rodney and Franklin.
- Greg has been asked to be on the "expenditure control & procurement committee" To undertake a line-by-line analysis of expenditure across the council to keep rates as low as possible and to safeguard essential services
- Greg gave an overview of the mayor's vision for Auckland.
  - Would like the CCOs to have a greater representation of industry expertise on the boards – eg: AT to have transport engineers on the board
  - Funding and budgets are in a dire position but is willing to address this issue with hard decisions
  - Fees and charges will still apply but wants to find savings of between 7-12%
  - Would like to reduce future rate increases for the ratepayers
  - Empower the community boards to have greater decision-making ability in their areas. Engage more with community groups.
  - Will support local expertise in relation to Hill Street and local roading
- Greg would like to see the consenting process reviewed

# Gary Heaven & Shelley Trotter

- Gary and Shelley have been trapping for many years on their land. But during the covid 2020 lockdowns they joined up to **Trapnz**. This website and tracking tool has enabled them to record and understand their predator control data. It has also enabled them to see the wider picture other predator control initiatives in our local area and throughout NZ

- Gave an overview of the vision to have a pest free peninsula including using an already partly formed barrier running Warkworth to Sandspit with a footprint across Hamilton Road incl Sharp Road and Monarch Downs.
- Volunteers are needed to make this happen. Individuals or groups welcomed
  - Volunteer to have a trap in your garden
  - Or Volunteer to check an existing trap or trap line in the neighbourhood eg: Te
    Whau walkway, Trotter Farm Trail tracks, along the cycleways, Lawrie Reserve etc
  - Or not happy to manage a trap yourself perhaps you can help collate your neighbourhood data onto the website

- Purpose: Assisting our local community in protecting, improving and expanding the shoreline ecosystems which are critical to the survival of our native birdlife and will result in enjoyment for all
- Our vision for a predator free programme "To increase the protection of bird life in Snells Beach by getting rid of rats, mice, mustelids, possums and hedgehogs and to contribute to the creation of a Predator Free Mahurangi Peninsula.'

### Action 1: Building a protective barrier from Mahurangi Road to the Shoreline

- Predator Trapping on Council and local landowners' land
- A Shoreline trap line from Sunburst to Boathouses (25 Traps)
- $\circ$  A Trapline on Little Shag Pond Arabella Road (5 traps)
- Brick Bay Winery (13 traps)
- o Involving a number of individuals in setting up traps on larger properties (14 traps)
- No poison used in any of the traps managed by SSCC

### Action 2: A Backyard trapping Programme

- Aims to have 1 in every 5 houses having a trap (long term plan)
- Received a small grant from Predator Free New Zealand and support from local council
- Has over 100 + traps to give away (starting from Shoreline upwards)
- Has 14 traps already in place
- $\circ$  All traps are safe for Children and pets no poison used in the bait
- Asks for donation so we can purchase more traaps

### Tim Armitage – Restore Rodney East <u>www.restorerodneyeast.org.nz</u>

**Vison** – to support and empower local environmental and conservation projects from Puhoi to Te Arai.

- Supports 45 groups within the Rodney East Area
- Has RLB funding
- Working on a discussion paper to assess the level of potential interest in a pest free peninsula project
- There are at least 18 interested parties on this Mahurangi Peninsula
- Snells Beach will be a key point in the pest free peninsula project.
- Takatu point/Tawharanui and the Miramar peninsula are examples of a successful implementation of a pest free vision.
- We can do it with a strong defence trap line from Warkworth to Sandspit and at points down to Scotts Landing
- Encourage everyone in the community to volunteer as able and help the community initiatives already in place.
